

# Shareholders' Intimation regarding certain changes in company's Preferential Issue details (for which members approval was obtained by circulating Extra-Ordinary General Meeting Notice dated January 25, 2024, and corrigendum thereto dated February 15, 2024)

# To,

The Members of Salasar Techno Engineering Ltd. and all other concerned.

In continuation of Notice of Extra-ordinary General Meeting dated January 25, 2024 and corrigendum thereof dated February 15, 2024 (collectively referred hereinafter as "EGM Notice") circulated to all the shareholders of the Company and consequent members approval obtained for the resolutions, as set out in the EGM Notice, with requisite majority, at their Extra Ordinary General Meeting held on February 19, 2024 we wish to inform the members and all other concerned regarding certain changes in Company's Preferential issue details, which are noted during process of obtaining Stock Exchanges In-Principle Approval.

# 1. Adjustment in Issue Price and Size

# A. Adjusted issue price

The Issue Price of Rs. 72/- per Equity Share/Warrant determined for the preferential issue in accordance with regulation 164 of the SEBI (ICDR) Regulations, 2018, being cum-bonus price, is adjusted in terms of Regulation 166 of the Regulations, as per the following details:






